

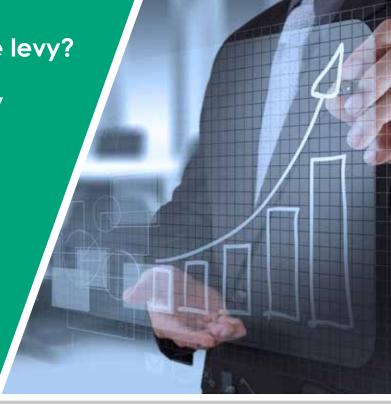
YOUR GUIDE TO THE APPRENTICESHIP LEVY

Is your business paying the levy?

Are you aware of how levy payments are calculated?

Are you spending the levy effectively?

Do you know government funding is available to support non-levy payers?



This is an initial guide to support employers wanting to recruit apprentices with Easton and Otley College.















WHAT IS THE APPRENTICESHIP LEVY?

The apprenticeship levy came into effect in April 2017 with first payments being made into the Apprenticeship Service (AS) in May 2017. The levy affects all organisations with an annual payroll over £3 million (including charities) whether or not you employ apprentices.

Changes have also been made to funding bands and there is now no upper age limit for undertaking an apprenticeship which means you can upskill your current staff with the levy.

DO I HAVE TO PAY THE LEVY?





If your pay bill is over £3M you will pay the levy at 0.5%





Funds made available via AS account plus Government 10% top up



Employer to register on the Apprenticeship Service (AS)





Funds can only be utilised towards the cost of apprenticeship training



Process repeats each financial year

HOW MUCH LEVY WILL I PAY?

You will pay the levy on your entire pay bill at a rate of 0.5%.

Your contribution calculation method:

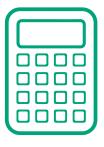
A = No of employees
B = Average Gross Salary
C = Payroll bill (A x B)

 $C \times 0.5\%$ = Levy sum payable

Example:

An employer has 200 employees, each earning a salary of £24,000.

200 (A) x 24,000 (B) = 4,800,000 (C) 4,800,000 (C) x 0.5% = 24,000 (less Government credit of £15,000)



NON-LEVY PAYERS - HOW CAN I RECRUIT APPRENTICES?

If your business does not pay the levy you can access Government funding towards supporting apprenticeships within your organisation. You will be required to contribute 10% and the Government will fund the remaining 90%.



Example:
If cost of
training
= £18,000

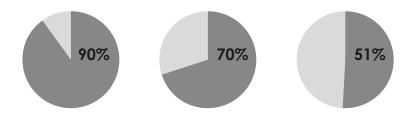


Employer contribution (10%) = £1,800

Government contribution (90%) = £16,200

WHY SHOULD I INVEST IN APPRENTICES?

- Apprentices can be any age upskill your current staff to gain competitive advantage
- 90% of apprentices stay in work post apprenticeship
- Over 70% of apprentices stay with their employers
- 51% of companies said average time for an apprentice to reach management was 5 years or less



HOW CAN I SPEND MY LEVY OR GOVERNMENT FUNDING ON APPRENTICESHIPS?

Don't waste your levy/government funding, it can be used in any part of your business and with any of your staff. Apprenticeship	Total Cost (Levy Payer)	Total Cost (Non-Levy Payer)	Duration
Customer Service Practitioner	£4,000	£400	12 months (minimum)
Golf Greenkeeper	£6,000	£600	20-24 months (minimum)
Heavy Vehicle Service & Maintenance Technician	£18,000	£800	36 months
Team Leader/Supervisor	£5,000	£500	24 months (minimum)
